  - •KC Writing Placement (Verbal score of 310 or higher AND Essay score of 3 or higher) within last 5 years
  - •Completion of prerequisite course English 100 with a "B" or better within last 5 years

  - •High school cumulative GPA of 3.0 or higher on an unweighted 4.0 scale within last 3 years
  - •GED or high school equivalency test score of 165 within last 18 months

  - •Completion of MATH 101 with a "C" or better within last 5 years
