The law requires that programs not having sufficient space and resources to accommodate all applicants will accept those applicants best qualified, using rank, ability and achievement test scores as guides, with preference given equally to students residing in the district or in a joint agreement district.

Information about Licensure

The following questions are taken directly from the application for the National Council Licensing Exam which you will take following completion of your program at KC. If you would answer "yes" to any of these questions, your exam application will be referred to the Committee on Nursing of the Department of Financial and Professional Regulation for review prior to your being eligible for exam or licensure. **PLEASE READ THEM CAREFULLY.** If there are any "YES" answers to the questions below the applying student shall speak to the Dean of Nursing at Kaskaskia College prior to submitting the application. Do not answer the questions on this page in writing.

- ◆ Have you ever been convicted of any criminal offense in any state or in federal court (other than minor traffic violations)?
- ◆ Have you had or do you now have any disease or condition that interferes with your ability to perform the essential functions of your profession, including any disease or condition generally regarded as chronic by the medical community, i.e.,
 - (1) mental or emotional disease or condition?
 - (2) alcohol or other substance abuse?
 - (3) disease or condition, that presently interferes with your ability to practice your profession?
- ◆ Have you ever been denied a professional license or permit, or privilege of taking an examination, or had a professional license or permit disciplined in any way by any licensing authority in Illinois or elsewhere?
- ◆ Have you ever been discharged other than honorably from the armed service or from a city, county, state or federal position?

All students will be required to have a background check and drug screening upon entry into the program.

3. **HS or H.E.S.** If you have previously submitted an official final high school transcript or official High School Equivalency score report, please do not submit again.
6. **ENGL** **Must have placement in English 101.** Placement is determined by one of the following:
 - ACT English score of 18 or higher within last 5 years
 - SAT Evidence-Based Reading and Writing score of 480 or higher within last 5 years
 - KC Writing Placement (Verbal score of 310 or higher AND Essay score of 3 or higher) within last 5 years
 - Completion of prerequisite course English 100 with a "B" or better within last 5 years
 - Completion of English 101 with a "C" or better within last 5 years
 - High school cumulative GPA of 3.0 or higher on an unweighted 4.0 scale within last 3 years
 - GED or high school equivalency test score of 165 within last 18 months
7. **MATH** **Must have placement in Math 102.** Placement is determined by one of the following:
 - ACT Math score of 17 or higher within last 5 years
 - SAT Math score of 460 or higher within last 5 years
 - KC Math Placement (ALEKS score of 14 or higher) within last 5 years
 - Accuplacer Test (QRAS or AAF 250 or higher) within last 5 years
 - Completion of MATH 101 with a "C" or better within last 5 years
 - High school cumulative GPA of 3.0 or higher on an unweighted 4.0 scale with successful completion of 4th year of math within last 18 months
 - GED or high school equivalency test score of 165 within last 18 months
8. **C.N.A.** * Attach proof of current employment as a Certified Nurse Assistant, such as letter from employer; **OR**
* Attach document from IDPH proving status is, or has been, active within the last two years; **OR**
* Successful completion of Kaskaskia College's IDPH approved CNA course with a "C" or better within the last academic term; **OR**
* Meet IDPH requirements for retesting if you have not worked as a CNA in the last two years; **OR**
* Meet program proficiency testing if you have previously been a CNA but not currently working and do not wish to work as a CNA.
