Do not answer the questions on this page in writing.

- ♦ Have you ever been convicted of any criminal offense in any state or in federal court (other than minor traffic violations)?
- ♦ Have you had or do you now have any disease or condition that interferes with your ability to perform the essential functions of your profession, including any disease or condition generally regarded as chronic by the medical community, i.e.,

 - (2) alcohol or other substance abuse?
 - (3) disease or condition, that presently interferes with your ability to practice your profession?
- ♦ Have you ever been denied a professional license or permit, or privilege of taking an examination, or had a professional license or permit disciplined in any way by any licensing authority in Illinois or elsewhere?

3. HS or H.E.S. If you have previously submitted an official final high school transcript or official High School Equivalency score report, please do not submit again.
6. ENGL **Must have placement in English 101.** Placement is determined by one of the following:
 - ACT English score of 18 or higher within last 5 years
 - SAT Evidence-Based Reading and Writing score of 480 or higher within last 5 years
 - KC Writing Placement (Verbal score of 310 or higher AND Essay score of 3 or higher) within last 5 years
 - Completion of prerequisite course English 100 with a "B" or better within last 5 years
 - Completion of English 101 with a "C" or better within last 5 years
 - High school cumulative GPA of 3.0 or higher on an unweighted 4.0 scale within last 3 years
 - GED or high school equivalency test score of 165 within last 18 months
7. MATH **Must have placement in Math 102.** Placement is determined by one of the following:
 - ACT Math score of 17 or higher within last 5 years
 - SAT Math score of 460 or higher within last 5 years
 - KC Math Placement (ALEKS score of 14 or higher) within last 5 years
 - Accuplacer Test (QRAS or AAF 250 or higher) within last 5 years
 - Completion of MATH 101 with a "C" or better within last 5 years
 - High school cumulative GPA of 3.0 or higher on an unweighted 4.0 scale with successful completion of 4th year of math within last 18 months
 - GED or high school equivalency test score of 165 within last 18 months
